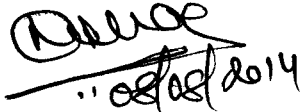
1. After the time fixed for closing of the poll by the Chairman, 2 ballot boxes were kept for polling and the same were locked in my presence with due identification marks placed on the same.
